1. PURPOSE

This Standard Operating Procedure (SOP) describes the Non-Medical Research Ethics Board (NMREB) communications with study participants involved in research overseen by the NMREB.

2. GENERAL POLICY STATEMENT

In the interests of enhancing human research participant protection and harmonization of policies and procedure, it is important for the NMREB to foster collaboration and open communication.

Research participants should be able to confidentially voice their concerns or questions, or request information regarding their participation, potential participation in a research project or rights as a research participant to an informed individual on the NMREB or in the Office of Human Research Ethics (OHRE).

3. RESPONSIBILITY

This SOP applies to the NMREB Chair, Vice-Chair(s), NMREB members, and OHRE staff.

5. SPECIFIC POLICIES AND PROCEDURES.

5.1. Communication with Research Participants

- 5.1.1.Research participants are encouraged to contact (by telephone, email or in writing) the OHRE with questions and concerns using the contact information provided in the informed consent document. If requested, the identity of the participant will not be recorded or shared;
- 5.1.2.OHRE staff relay communications promptly to the NMREB Chair or Vice-Chair(s) when the participant shares concerns or problems encountered with a research project;

- 5.1.3. The NMREB Chair, Vice-Chair(s) or designee works to resolve participant issues, including follow-up with the Investigator or the Investigator's supervisor or institutional official and appropriate federal agencies, as indicated;
- 5.1.4. The NMREB Chair, Vice-Chair(s) or designee documents communication with the research participant and keeps a record on file at the OHRE.
